### Army Tuition Assistance (TA)

- ◇ Pays directly to the university the cost of credits for courses approved by the federal agency (up to 16 credits per fiscal year).
- ◇ Up to \$250 per semester hour, up to 18 SHs for a total of \$4,500 per fiscal year.
- ◇ The student is the one who applies for the benefit through the **ArmyIgnitEd** portal or with the help of an Army Education specialist.
- ◇ TA will not approve aid after the beginning of the academic term.
- ◇ Maintain a 2.0 or higher GPA for undergraduate courses or a 3.0 or higher GPA for graduate courses.

### Montgomery GI Bill® Selected Reserve

- ◇ The Montgomery GI Bill® Selected Reserve (MGIB-SR) program offers up to 36 months of education and training benefits. If you're a member of the Army, Navy, Air Force, Marine Corps or Coast Guard Reserve, Army National Guard, or Air National Guard, you may be eligible for this benefit.
- ◇ For Reservists with a six-year obligation in the Selected Reserve who are actively drilling.
- ◇ Complete your initial active duty for training (IADT).
- ◇ Basic monthly allowance
- ◇ Benefit **DOES NOT** pay tuition

### Montgomery GI Bill® Active Duty

- ◇ The Montgomery GI Bill® Active Duty (MGIB-AD) can help you pay for education and training programs. If you've served at least 2 years on active duty.
- ◇ You may be eligible for education benefits through this program if you were honorably discharged and you meet the requirements of one of the categories below.
- ◇ You may get up to 36 months of education benefits.
- ◇ Benefit **DOES NOT** pay tuition
- ◇ To receive payments you must confirm your attendance to the courses on the last day of each month through the WAVE system or by phone at 1 (877) 823-2378.

## Chapter 33 Post 9/11 GI Bill®

- ◇ Calls to service under Title 10 on or after September 10, 2001 and have completed 90 days or more.
- ◇ The Post-9/11 GI Bill® provides up to 36 months of education benefits.
- ◇ **If your service ended before January 1, 2013**, your Post-9/11 GI Bill (Chapter 33) benefits will expire 15 years after your last separation date from active service.
- ◇ **If your service ended on or after January 1, 2013**, your benefits won't expire thanks to a new law called the Forever GI Bill® - Harry W. Colmery Veterans Educational Assistance Act.
- ◇ Pay tuition costs directly to the Institution, according to the percentage of eligibility (50% - 100%)
- ◇ Monthly housing allowance
- ◇ Annual books and supplies stipend
- ◇ If you're a qualified service member, you can transfer all 36 months or a portion of your Post-9/11 GI Bill® benefits to a spouse or child.
- ◇ Private School up to per academic year \$29,920.95 (Effective August 1, 2025)

## Chapter 31 "VR&E" Program

### Veterans Vocational Readiness and Employment

- ◇ If you have a service-connected disability that limits your ability to work or prevents you from working, Veteran Readiness and Employment (formerly called Vocational Rehabilitation and Employment).
- ◇ Must be evaluated and referred by a Vocational Rehabilitation counselor from a regional veteran service office.
- ◇ Electronic authorization through Tungsten Portal
- ◇ If you qualify for study aid, this pays the university 100% of the tuition costs, among other benefits.

## Capítulo 35—DEA DEPENDENDANTS AND SURVIVORS

- ◇ If you're a dependent spouse or child—or the surviving spouse or child—of a Veteran, you may qualify for Chapter 35 benefits
- ◇ If you're the child of a Veteran or service member you can get benefits if you're between the ages of 18 and 26, except in certain cases. You may be married or unmarried.
- ◇ **45 months** if the first use of benefits was before August 1, 2018
- ◇ **36 months** if the first use of benefits was after August 1, 2018 If you began using the program on or after August 1, 2018, you can get benefits for up to 36 months.
- ◇ The current monthly payment for full-time training is \$1,488
